Judy's easy smile and enthusiasm for serving families in our community was contagious to all those around her. Court Advocates for Children feels a great loss.

Research reveals that the connection parents make with their children shapes and influences the child's journey through life. Court Advocates for Children observes first-hand how children's connection with their parent(s) is disrupted when they enter the child welfare system through a dependency action. Family Foster Care can help to minimalize the disruption by providing a nurturing transition and maintaining a connection with the family of origin.

In family foster care, children live with relative or nonrelative adults who have been approved by the State, or by an agency licensed by the State, to provide them with shelter and care. As a community, it is important to support the family foster care (aka caregivers) through this process and acknowledge the efforts they make to create a nurturing home for the children they will foster-parent for an undetermined period of time. These caregivers are responsible to enroll the children in school, taking them to well-child visits, and providing emotional support as the child(ren) transitions to an unfamiliar environment(i.e. new home, new bed, and new schedule). The caregivers witness the results of children who have been living in an unhealthy environment such as issues of mental health, substance abuse, and/or homelessness. Often the child(ren) is coming from a chaotic environment lacking routines or a sense of normalcy. These children learn for the first time what it is like to have a consistent schedule; get up and go to school, eat regular meals, and go to bed at a regular time.

It goes without saying that biological parents love their children, but often their own struggles, lack of support and resources get in the way of parenting. Family foster care can provide a safe transition period while the biological parents get the support needed to resume parenting in a safe and stable environment.

When children cannot remain safely in their home, placement in family foster care can increase stability, reduce trauma, and help children maintain a sense of family, belonging, and identity. A caregiver in family foster care has the opportunity to provide encouragement and hope in a child's life.

CHILD ABUSE PREVENTION MONTH - APRIL

April is National Child Abuse Prevention Month.

Each year, nearly 6,000 children in Washington State experience abuse or neglect, ushering them into the dependency court and foster care systems. A child in foster care, on average, will move into multiple homes and attend multiple schools. All this chaos and inconsistency has long-term effects.

Court Advocates for Children runs a campaign (#childabusepreventionmonth, #thrivingfamilies) each year to spread awareness and gain support in Kittitas County. The month is full of presentations to community

THE IMPACT OF POVERTY ON FAMILIES

Hello, my name is Audrey Higginbotham I am originally from Buckley, but I have been living in Ellensburg for the past four years. I am currently a fourth-year student at Central Washington University, studying social services and family science. I have been interning with Court Advocates for Children since April 1, 2022.

During my internship with Court Advocates for Children I have experienced how impactful child advocates can be and have learned how much effort and energy goes into preparing for court and advocating for the child with their best interest at heart. I have recognized how classes I am taking or have taken directly relate to the demographic of families Court Advocates for Children serve and would like to share a recent study.


As a part of my Family and Public Policy class at CWU, I participated in a poverty simulation. This simulation is intended to give its participants insight into the struggles families who are experiencing poverty face. The key takeaways from this simulation are, that poverty is stressful and there is a lack of knowledge about the resources available. Many of the families in poverty are continuously in survival mode, working for food money, and other necessities or trying to pay rent and keep a roof over their heads. Those who have children are trying to balance those stressors along with caring for their children. As a community we can better help these families by understanding the resources available and how to access them. Spreading awareness and providing support to available resources can help to alleviate some stress for the families in need.

Many of the families Court Advocates for Children serves are living in poverty and therefore struggling with the stresses that come with it. As child advocates, understanding the constant stress that these families experience as well as acknowledging how this stress can impact the

children within the families helps us to better serve them. Supporting the families we serve by informing them of resources (i.e., services and programs) available can also be very beneficial in getting them on track to having a more stable home life.


